

## REQUEST FOR POSITION REVIEW FORM

### Background and Instructions

Apart from the Claims Process, a neutral independent expert will conduct a review of all GS-14 and GS-15 Agent-only positions at FBI HQ and affiliated offices (Quantico, Newington and CJIS) to ensure that they are properly designated. The review will be ongoing until June 28, 2010. It is part of the programmatic relief under the Settlement and is intended to benefit the Agency as a whole. There is no individual relief attendant to this process.

At any point during the review process, you as a class member may request that the independent expert review a subject position to ensure that it is properly designated Agent-only or not. While she is to review all such positions, your request will highlight the need for review and help her prioritize. It may also call a position to her attention that was omitted from the list provided her. You may be aware of the Agent-only position by way of a formal vacancy announcement, word-of-mouth, or by some informal event in your workplace. The request may relate to any current or prospective Agent-only designation, including a long-standing position, a newly forming (impending) position, or a temporary situation. You may submit more than one form.

The Position Designation Review process is entirely independent of the Claims Process. **Filing a Request for Review Form with the expert does not satisfy the requirement of filing the Basic and Comprehensive Claim Forms under the Claims Process. Only the Claims Process provides for individual class member monetary damages and/or job relief.** You may pursue both the Claims Process and file a Request for Review. The latter Request for Review Form may be filed at any time during the term of the Settlement Agreement (until June 2010) and must relate to a current or prospective position. To be eligible for relief under the Claims Process, the Basic and Comprehensive Claim Forms must be filed by September 5, 2006 and December 6, 2006, respectively.
